Alternatives in Administration Frequencies of Ertapenem in Critically III Patients with Hypoalbuminemia By Reshma Singh PharmD Candidate 2019, USJ School of Pharmacy; and Judy Huang PhD, PharmD, BCPS, Bridgeport Hospital

Recent studies conducted in critically ill patients favor a change in ertapenem administration from once-daily bolus dosing to twice daily dosing or continuous infusion after a loading dose. Ertapenem is a broad-spectrum carbapenem FDA approved for the treatment of intra-abdominal infection, complicated skin infections, UTIs, and CAP.¹ Unlike other carbapenems, ertapenem is 85–95% protein bound which contributes to its allowance for a once daily dosing regimen.¹ In critical care patients, hypoalbuminemia is a common finding.² Hypoalbuminemia contributes to higher morbidity and mortality rates when compared to patients with a normal serum albumin.³ Multiple studies have shown that ertapenem concentrations negatively correlate with hypoalbuminemia. Ertapenem concentrations taken over 3 days in a cohort of 9 adults were found to be frequently below the susceptibility breakpoint.⁴ Similarly, a cohort of 17 septic patients with hypoalbuminemia given ertapenem had failed to maintain effective MIC levels throughout the once daily dosing interval.⁵ CLICK to read the full article

Clinical Pearl: Drug Update-Epidiolex (cannabidiol) Oral Solution

The FDA approved Epidiolex* (cannabidiol) oral solution on June 25th, 2018 for the treatment of seizures associated with Lennox-Gastaut syndrome (LGS) and Dravet syndrome in patients 2 years old and older. LGS and Dravet syndrome are rare, severe form of epileptic encephalopathy that are usually treatment resistance to available medications. Cannabidiol drug is the first drug approved by the FDA for the treatment of patients with Dravet syndrome. Cannabidiol is also the first FDA approved drug that contains purified drug substance from cannabinoid.

FDA Releases Revises Draft Compounding Memorandum of Understanding

On September 7th, FDA released a revised Memorandum of Understanding (MOU) meant to govern compounding oversight between states and the FDA. The new draft, which revises a 2015 version, allows additional flexibility to compounders and states. Although FDA retained language referring to both dispensing and distributing (ASHP has commented that dispensing, which is done pursuant to a patient prescription, is a practice of pharmacy/medicine issue outside of FDA's jurisdiction), the FDA did increase the limit on how much compounded medication can be dispensed or distributed interstate from 30% to 50% of a pharmacy's total interstate and intrastate monthly orders. Pharmacies exceeding the 50% threshold are considered to be dispensing and/or distributing an "inordinate amount" of compounded medication over state lines which will trigger state reporting to FDA. The MOU also provides states

additional flexibility in how they may gather information related to both pharmacy and physician interstate distribution/dispensing of compounded medication. It is important to note that the limits in the MOU do not apply to registered 503B outsourcing facilities. However, there is no explicit carve out for hospitals and health systems, so interstate distribution limits may apply even if the FDA removes the one-mile radius from the hospital/health system compounding guidance. States will need to individually ratify the MOU. In states that do not adopt the MOU, the limit for interstate dispensing will be set at 5% of total monthly orders. ASHP will be submitting comments to FDA by the close of the 90-day comment period. (source: ASHP 9.10.18)
