Call for Poster Abstracts

CSHP's *Catch the Wave* Conference Committee is pleased to announce a **call for posters**.

The CSHP Annual *Catch the Wave and Greg Gousse Residency Conference* will take place on **November 9th, 2023** at the Double Tree by Hilton in Bristol, CT.

The deadline for receipt of abstract submission is **October 1, 2023**.

All current CSHP members registered to attend the conference are eligible to apply. You may submit an abstract or poster that has been presented at a meeting of a different organization.

Presenting a poster is an excellent opportunity to enhance your professional curriculum vitae and/or resumé, gain valuable experience in abstract and poster writing, practice presenting research data to a captive audience, and share with the pharmacy community all the great things you and your institution have been doing recently. In addition to presenting your abstract, with your permission, will be printed in the CSHP *News Brief* and posted on the CSHP web site with credit given to your co-writers.

To submit a poster for the meeting, please email Stefanie.Zassman2@ynhh.org with the following [**deadline: October 1, 2023**]:

- **In the body of the email include:**
 - Primary presenter's full name
 - Organization/School
 - Indication of placement in pharmacy career
 - Pharmacy Student (not yet on APPE rotations)
 - Pharmacy Student (final year – on APPE rotations)
 - PGY1 Resident
 - PGY2 Resident
 - Practicing Pharmacist
 - Other: _____
 - Poster Authors: in order they appear – include first name, middle initial, last name, credentials and employers of other poster authors (recommendation: limit to 4 names)
- **Attach your abstract to the email. You do not have to send your poster.**

Abstracts should include a purpose, methods, results and conclusions, and consist of no more than 400 words in length. When applicable, the abstract must indicate that the clinical research was approved by the appropriate ethics committee or institutional review board (IRB), and if appropriate, informed consent was obtained for all subjects. If IRB approval was deemed not necessary, there should be a statement that approval was not required.

To ensure high quality presentations, we encourage all presenters to have their abstract and poster reviewed by their mentor/preceptor prior to submission. Every attempt will be made to accommodate all submissions. However, in the event that submissions exceed allotted time, only selected posters will be presented.

For more information regarding abstract content/format/poster size, please refer to ASHP's guidelines for poster abstract submissions. Posters of any size may be presented.
