LEGISLATIVE UPDATE

ASHP Needs Your Help

ASHP needs you to ask Congress to remove payment barriers for pharmacists to provide testing and vaccination services to Medicare beneficiaries. Urge Congress to include pharmacist reimbursement for COVID-19 testing and vaccination services for Medicare beneficiaries.



Over the past several months, states and federal regulatory agencies have pushed for pharmacists to be authorized to order and administer tests and provide vaccination services as part of the COVID-19 response. Now Congress needs to step up and remove payment barriers for pharmacists to provide these services to Medicare patients.

Please send a letter to your federal legislators urging them to allow pharmacist reimbursement in the next round of COVID-19 response legislation. Ask your colleagues in the pharmacy department to join you. Every voice counts!

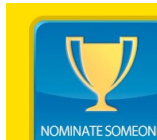

First Connecticut Residency Conference

With the cancellation of the Eastern States Residency Conference, in the midst of the COVID-19 pandemic, residents around the state needed an alternative venue to present their residency projects. CSHP stepped in and organized the 1st CT Residency Conference for all PGY1 and PGY2 residents in the state, held virtually on May 28th. Over the course of the daytime event, 54 residents presented platform presentations and 7 residents presented posters. Eight additional residents presented as part of The Great 8 CE program that evening.

Over the course of the day, we had 220 participants who attended presentations for an average of three hours each. Over 120 evaluations were completed, providing valuable feedback to our residents. A special thanks goes out to all of the residency directors, preceptors, and pharmacists from around the state who served as session moderators and designated providers of feedback. We could not have pulled this event off without your help!

We greatly appreciate all of the comments and feedback we've received following the event and we look forward to making this an annual event (hopefully in person next year)!

What's New with Cholesterol? A Review of Updates for Prevention of Atherosclerotic Cardiovascular Disease

Introduction

Atherosclerosis is a leading cause of cardiovascular disease (CVD) in the US. CVD of atherosclerotic origin, including peripheral artery disease, stroke, trans ischemic attack, acute coronary syndromes, and stable angina, are collectively termed atherosclerotic CVD (ASCVD). Hyperlipidemia has been identified as a significant risk factor for the development of ASCVD.¹ Correspondingly, management of blood cholesterol including total serum cholesterol and its lipoprotein carriers, low-density lipoprotein (LDL), very low-density lipoprotein (VLDL), high-density lipoprotein (HDL), is important for reducing the risk of ASCVD.¹ In addition to serum cholesterol laboratory values, there are numerous additional factors which have been implicated in patients' ASCVD risk profiles. These risks have been classified as either major risk factors or risk enhancers.¹ Collectively, evaluation of patient's serum cholesterol and additional risks is used to determine patient-specific ASCVD risk.
